RE: NOTICE OF APPLICATION FOR AN ELECTRICITY GENERATION LICENCE PURSUANT TO SECTION 64 OF THE ELECTRIC POWER SECTOR REFORM ACT 2005

## AN OBJECTION

Our attention has been drawn to a Public Notice published in the Guardian, Sunday May 7, 2006 at page 49 on the subject matter first above mentioned.

The Public Notice was issued by one Alliance Energy Limited of Plot 3354 Lomela Close, off Osun Crescent, Ministers Hill, Maitama Abuja, notifying the general public of its application for an intention to be granted an Electricity Generation Licence to generate electricity in Onne Oil and Gas Free Zone.

This is therefore an objection to the application for the grant of Electricity Generation Licence to generate electricity in Onne Oil and Gas Free Zone, as applied for by Alliance Energy Limited and published in the said Public Notice. Our objection is based on the following premises:

- That we, Thames Energy Nigeria Limited, were issued an Electricity Licence No. 17768 for the entire area covering the Onne Oil and Gas Free Zone by Federal Ministry of Power and Steel, Abuja on the 24<sup>th</sup> day of December 2004 under the now repeated Electricity Act Chapter 106 Laws of the Federation of Nigeria, 1990 (see attached documents).
- That the said Electricity Licence No. 17768 confers on us the right to generate transmit and distribute electricity in Onne Oil and Gas Free Zone for an initial period of 20 years.

- That the combine provisions of Sections 98(1), (2) and (5) of the Electric Power Sector Reform Act 2005 preserves and validates the Electricity Licence No. 17768 granted to THAMES ENERGY NIGERIA LIMITED as aforesaid.
- That to allow the application of Alliance Energy Limited for the grant of an Electricity Generation Licence to generate electricity in the Onne Oil and Gas Free Zone being the same area covered by our Electricity Licence No. 17768 will;
  - be an unfortunate duplication capable of undermining the policy thrust of the Federal Government in the power sector,
  - sends wrong signals as to the sincerity of Nigerian Electricity Regulatory Commission (NERC) and indeed the Federal Government towards solving the problem associated with providing electricity in Nigeria,
  - be contrary to the spirit and intendment of the Electric Power Sector Reform Act,
  - d. cause us unimaginable financial loss and attendant liabilities, and
  - e. erode investors' confidence and render the project unattractive to investors.
- 5. THAMES ENERGY NIGERIA LIMITED is an indigenous company with solid track record in the power sector. Our efforts towards the provision of an independent source of electricity to the Onne Oil and Gas Free Zone started back in the 2001, after conducting detailed studies and research, and receiving approvals from the various departments of the Federal Ministry of Power and Steel leading to the grant of the electricity Licence in December 2004.

Our commitment to the project has remained clear and sustained, we therefore ask for your encouragement and support towards the actualization of this noble venture.

## ELECTRICITY ACT (Chapter 106)

### ELECTRICITY SUPPLY REGULATIONS

### ELECTRICITY LICENCE

In exercise of the powers conferred by regulations 22 to 35 of the Electrical Supply Regulations 1990	, the
Minister of Power and Steel (hereinafter referred to as "the Minister") hereby grant THAMES ENERGY NIG. LTD of 53 TOMBIA STREET	s to
THAMES ENERGY MIG. LID. of 53 TOMBIA STREET	
GRA PORT HAR COURT (hereinafter referred to as "the licensee") licence to-	

- (1) use and work electrical generating plant described in the First Schedule hereto;
- (2) supply electrical energy within the area of supply described in the Second Schedule;
- (3) construct and use electrical lines between the area of supply described in the Second Schedule hereto for the express purpose of supplying electrical energy from any one area to any other area described in the said Second Schedule; and
- (4) use electrical energy within the said area of supply for the purposes specified in the Third Schedule o; and subject to the following conditions
- (a) to operate the said electrical generating plant, apparatus and works, and to supply and use electrical energy in accordance with the provisions of the Electricity Act or any enactment replacing the said Act and in accordance with any regulations, orders or rules made thereunder;
- (b) not to supply or permit to be supplied electrical energy for any purpose other than those specified in the Third Schedule hereto without the previous written consent of the Minister which may be subject to such conditions as the Minister may see fit to impose and which consent may be withinked or cancelled by the Minister in his discretion;
- (c) to pay compensation for any infringement of rights of, or any damage proved to have been caused by the licensee to any person or body corporate or any native community by the operation of the said plant or of any works connected therewith, and to accept as final the decision of the Minister as to the amount of any such compensation;
- (d) to execute to the satisfaction of the Minister such agreements as he may require in relation to any property real or personal other than property in occupation of or belonging to the licensee, which may be adversely affected by the operations of the said plant or by any works whatsoever connected therewith;
- (c) to cease to operate the electrical generating plant described in the said First Schedule hereto otherwise than for the purposes set out and subject to the conditions specified in the Fourth Schedule hereto within ninety days following the service of a written notice in conformity with Supply Regulation 28 of the Electricity Act (Cap 106); and (f) not to assign the licence hereby granted.
- 2. The Minister shall, at any time a breach of any of the foregoing conditions is committed, caused to be served on the licensee notice of such breach and if the licensee fails to remedy the breach within ninety days from the date of the said notice this licensee shall be automatically revoked. The licensee shall upon such revocation cease forthwith to operate the said plant or to supply or use electrical energy and shall have no claim whatsoever to compensation or damages against any Government of the Federation in respect thereof.

## FOURTH SCHEDULE

- A. The Electrical Generating Plant specifica in the First Schedule shall only be operated if
- (i) due to break-down of plant or damage to electric lines of the Supply Authority in the area concerned (neremafter referred to as the Supply Authority), the supply of electrical energy ceases to be available to the Licensee's premises, or
- (2) the Supply Authority fails to maintain a full supply of electrical energy sufficient to enable the Licensee to operate his installation at full capacity. For the purpose of this Part, full supply shall be deemed to mean a supply of electrical energy not less than that contracted for between the Licensee and the Supply Authority or if the limits of variation prescribed by Regulations as regards pressure or frequency of supply are exceeded to such an extent as to adversely affect or entirely prevent the operation of the Licensee's electrical installation; but in the event of any dispute between the Supply Authority and the Licensee as to what is "full supply", the dispute shall be referred to the license, Electrical Inspectorate Services, Ministry of Fower and Seed, whose decision shall be final and binding on the Supply Authority and the Licensee, or
  - (3) the Supply Authority requests the Licensee to operate it.
  - B. The operation of the electrical generating plant shall be subject to the following special requirements:
  - (1) The licensee shall not operate the electrical generators in parallel with the Supply Authority's system.
- (2) the electrical generators shall be connected to that part or parts or the whole of the Licensee's installations it is desired to supply from the electrical generators, by means of a special changeover switch or switches, to be of a type approved in writing by the Director, Electrical inspectorate Services, which changeover switch must disconnect the Supply Authority's supply system from that part of the Licensee's electrical installation to be supplied from his gamerating plant.

It shall cease to be used as soon as may be practical following notification by the Supply Authority dia:
