COMMISSION'S DIRECTIVE ON THE ISSUE OF NON-COMPLIANCE OF ENUGU ELECTRICITY DISTRIBUTION PLC (EEDC) WITH THE ELECTRIC POWER SECTOR REFORM (EPSR) ACT, 2005, ELECTRICITY DISTRIBUTION LICENCE TERMS AND CONDITIONS, AND OTHER REGULATORY INSTRUMENTS ISSUED BY THE NIGERIAN ELECTRICITY REGULATORY COMMISSION (NERC)

## **BACKGROUND:**

Pursuant to Section 62 (7) of the EPSR Act 2005 and Regulation 5(1) (a) and 11 of the NERC Electricity Industry (Enforcement) Regulations 2014, the Commission commenced Enforcement Actions against Enugu Electricity Distribution Company (EEEDC) vide a Notice dated June 9, 2016, for non compliance with the provisions of the EPSR Act, 2005, Electricity Distribution Licence Terms and Conditions, and other Regulatory Instruments of the Commission.

#### **SUMMARY OF FACTS**

- In realization of the Commission's objectives of maximizing access to electricity services by promoting and facilitating consumer connections to distribution systems in both rural and urban areas as enshrined under Section 32 (1) (b) of the EPSR Act, 2005, the Commission directed that you submit quarterly reports to update its database on Distribution Network Expansion and Reinforcement across the distribution companies.
- 2. The Commission having observed that EEDC failed, refused or neglected to submit the outstanding report on the quarterly added distribution network inventory, had made repeated demands for EEDC to submit the Added Distribution Network inventory as contained in the templates earlier issued to EEDC, indicating business unit/locations where these additions were deployed.
- 3. However, EEDC Electricity Distribution Company (EEDC) failed or refused to provide the Commission with the outstanding 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> quarters in 2015 and 1<sup>st</sup> quarter in 2016 in the prescribed format, in spite of repeated demands from the Commission.
- 4. Consequently, the Commission issued a Notice of Intention to Commence Enforcement (NICE) to EEDC dated June 9, 2016 to "SHOW CAUSE" within Seven (7) days, why Enforcement Action should not be taken against EEDC for violating:
  - Section 63 (1) of the EPSR Act 2005 which provides that; "A licensee shall comply with the provisions of its license, regulations, codes and other requirements issued by the Commission from time to time".

• Condition 4 of the Terms and Conditions of the Distribution Licence issued to EEDC by the Commission; "The licensee shall furnish to the Commission, in such manner and at such times as the Commission may require, such information and shall provide and furnish to it such reports as the Commission may consider necessary in the light of the conditions or as it may require for the purpose of performing the functions assigned or transferred to it by or under the Act".

## **FINDINGS**

EEDC despite the repeated demands to submit the Added Distribution Network inventory by the Commission failed to comply.

#### **PENALTY**

In view of the above findings, the Commission is convinced that you have committed the breaches mentioned above, and hereby directs as follows:

- 1. For failing to comply with the Terms and Conditions of licence, thus breaching the provision of Section 63 (1) of the EPSR Act, by failing to submit 2<sup>nd</sup> quarter report in 2015. Consequently, the Commission hereby fines EEDC N10, 000. 00 (Ten Thousand Naira) per day from April 15, 2015 to date (25/7/16) giving a total of N4, 670, 000. 00 (Four Million, Six Hundred and Seventy Thousand Naira),
- 2. By failing to submit 3<sup>rd</sup> quarter report in 2015, the Commission fines EEDC N10, 000.00 (Ten Thousand Naira) per day from July 15, 2015 to date (25/7/2016) giving a total of N3, 760, 000.00 (Three Million Seven Hundred and Sixty Thousand Naira),
- 3. By failing to submit 4<sup>th</sup> quarter report in 2015, the Commission fines EEDC N10, 000. 00 (Ten Thousand Naira) per day from October 15, 2015 to date (25/7/2016) giving a total of N2, 840, 000. 00 (Two Million Eight Hundred and Forty Thousand Naira),
- 4. By failing to submit 1<sup>st</sup> quarter report in 2016, the Commission fines EEDC, N10 000. 00 (Ten Thousand Naira) per day from January 15, 2016 to date (25/7/1016) giving a total of N1, 920, 000.00 (One Million, Nine Hundred and Twenty Thousand Naira)

- 5. The sum of Thirteen Million One Hundred and Ninety Naira (\stacksquare) 130, 000.00) shall be paid by EEDC within two (2) weeks from the date of this directive.
- 6. Failure to pay the fines within the stipulated time shall attract additional interest of 5% per day, until the total fine is paid.
