

ORDER/NERC/2024/036A

BEFORE THE NIGERIAN ELECTRICITY REGULATORY COMMISSION IN THE MATTER OF THE APPROVAL OF 11kV AND 33kV FEEDERS FOR BAND A SERVICE BY PORT HARCOURT ELECTRICITY DISTRIBUTION PLC

This regulatory instrument shall be cited as Addendum – 1 to the April 2024 Supplementary Order for Port Harcourt Electricity Distribution Plc ("PHED")

- 2. Pursuant to the April 2024 Supplementary Order No. NERC/2024/036 for Port Harcourt DisCo, the Commission has reviewed and considered PHED's request for additional feeders to be classified as Band A. Accordingly, the Commission hereby approves additional Two (2) Nos of 11kV and Six (6) Nos of 33kV feeders provided in schedules 1 and 2 below to have met the minimum service requirements and be reclassified as Band A Feeders.
- 3. PHED shall ensure that only the customer or group of customers directly connected to the approved 33kV feeders are billed at the Band A tariff. Where there are 11kV feeders radiating from the approved 33kV feeders, such 11kV feeders shall not be automatically classified as Band A. The 11kV feeders in this category must be presented for independent evaluation based on their reported service levels.
- 4. PHED shall henceforth include the newly approved Band A feeders in its daily online reporting.
- 5. The Commission shall continue to monitor the performance of all the feeders to ensure compliance with the committed level of service.
